

| 8. | SCDC Local Plan Review and to receive an update on the 1-2-1 meeting held with SCDC |
| | The Chairman provided details regarding a meeting in which himself, Cllr Galloway and Cllr Pulham had attended on 18 th October 2017. He gave details regarding timings for the completion of the review of SCDC's Local Plan. The Chairman advised that from SCDC had stated he would be willing to attend a future NPSG meeting at Kelsale suggested the outcomes of the Parish Plan should feed into this document. Cllr Ellis gave details regarding the process for the Call out for Sites Consultation and the sites entered within the review of the Local Plan Consultation. There was a discussion regarding the sites submitted for possible development and gave details regarding the land within and surrounding Kelsale-cum-Carlton. Cllr Pulham gave details regarding site 1020 and confirmed he would supply details regarding this land at the next meeting and stated this site has plans to be allocated as a housing estate. The Clerk asked the Chairman if they had asked for any clarification regarding the number of homes at Carlton Meres being included within the Parishes housing stock. The Chairman stated that SCDC had not provided any details in respect of the questions asked in respect of Carlton Meres.
