

Annual Governance and Accountability Return

Each year Kelsale-cum-Carlton Parish Council is required by law to complete an Annual Governance and Accountability Return. This return ensures that all financial business conducted by the Council is legally compliant.

To enable the Council to be as transparent and accountable as possible, the following documents are available to the public to view:

1. Annual Internal Audit Report 2017/2018

This report has been completed by the local authority's internal auditor who acts independently on behalf of local town and parish councils. They have examined pre-defined objectives based on the end of year accounts provided by the Responsible Finance Officer (the Clerk). The findings of the examination confirms that all objectives have been met.

2. Annual Governance Statement 2017/2018

This statement confirms that there is a robust system of internal control and clear effective financial management.

3. Accounting Statements 2017/2018

These statements show a comparison of year end totals as at 31st March 2017 and 31st March 2018. The end of year financial accounts were presented, ratified and signed at the Parish Council meeting held on 30th May 2018. Copies of the year end accounts are available to view on the website.
